

## SMAC Priorities for the local 2018 NOFA competition

Based on the data provided below SMAC Governing Board has voted on the following for priority funding targets during the 2018 local SMAC NOFA competition:

### 1) Priority be given to projects that target Washington County as their primary service area.

*Justification:*

- a. Washington County receives few monetary resources than any of the other SMAC communities from the CoC and from state funders.
- b. Washington County has the fewest units available for homeless households based on the 2018 Housing Inventory Chart.
- c. Washington County had the second highest unsheltered number during the 2018 Point in Time count.

### 2) Priority be given to projects that provide Permanent Supportive Housing to youth.

*Justification:*

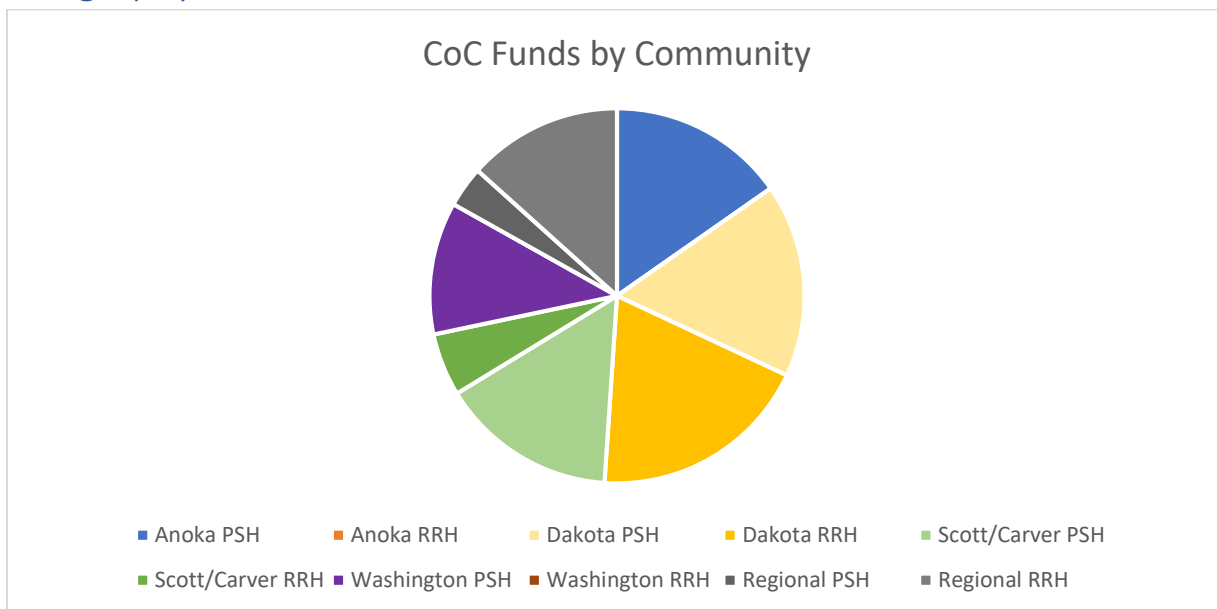
- a. Youth and youth headed households currently make up 35% of the SMAC Coordinated Entry priority list and 22% of the total PSH list. This is a trend SMAC has seen since Coordinated Entry began in 2015.
- b. Youth specific PSH only makes up 5% of the 2018 Housing Inventory Chart.

### 3) Priority be given to projects that provide Rapid Rehousing to Singles.

*Justification:*

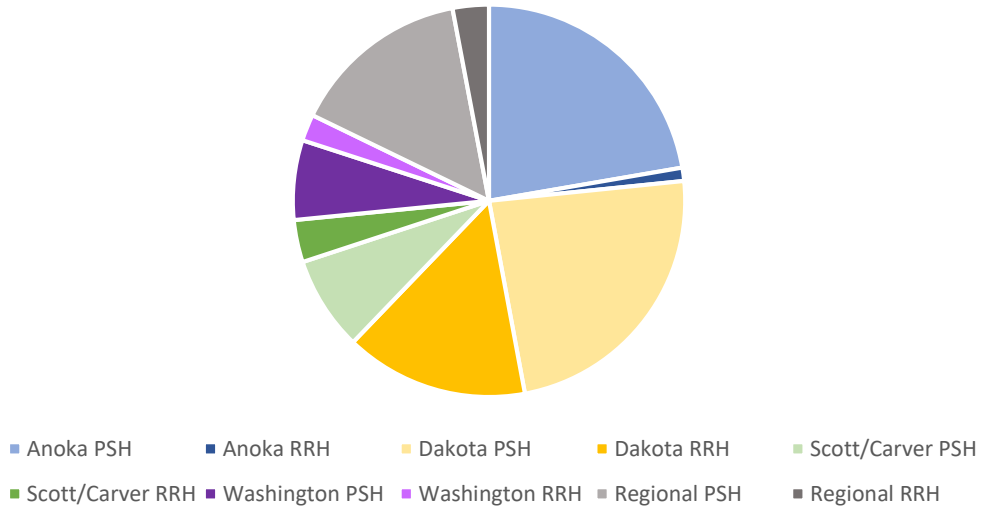
- a. Rapid Re Housing for singles currently only make up 4% of the SMAC HIC.

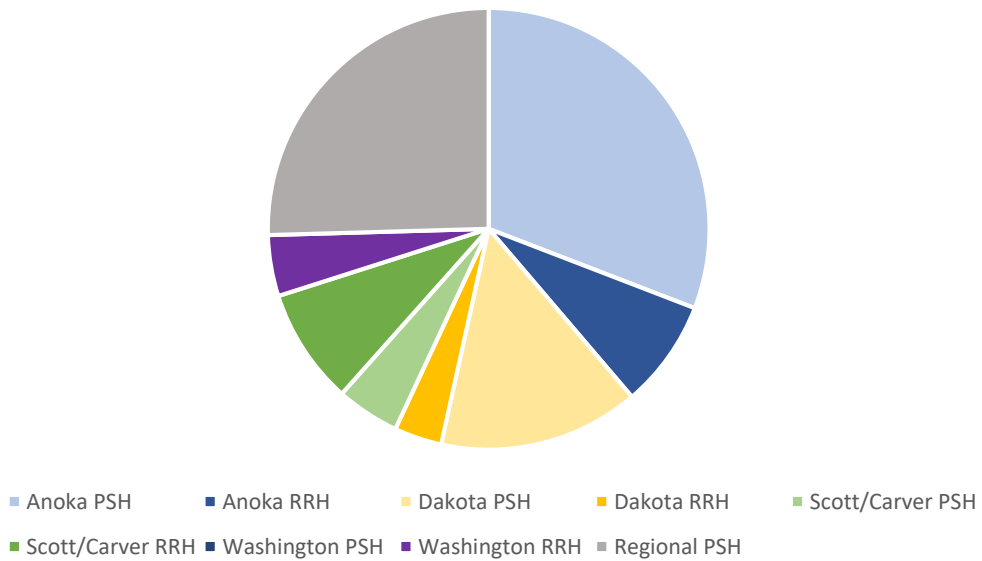

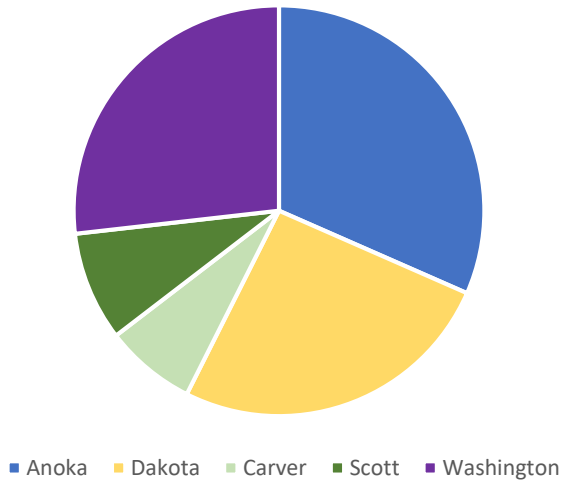

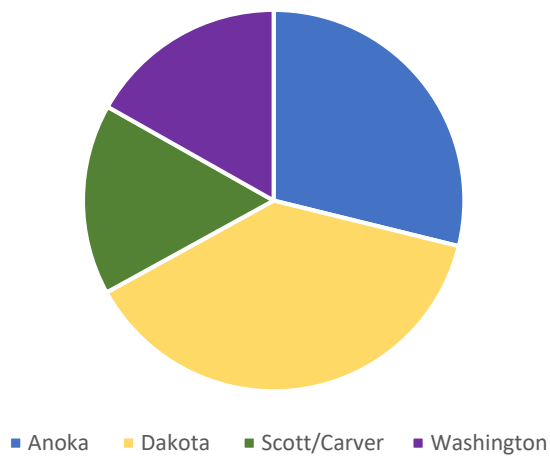

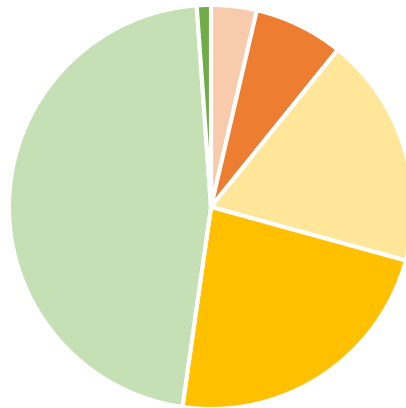
Coordinated Entry Data as of 6/28/18 by Community
